4. Pre-bid meeting for **SD/G/NCB/2080/81/07** shall be held at **Survey Department, Min Bhawan, Kathmandu** at 14:00 on January 4, 2024.
5. Interested Bidders shall submit the electronic Bids through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the above office of **Survey Department, Min Bhawan, Kathmandu** as mentioned on above dates. Bids received after this deadline will be rejected.
6. Bids shall be opened in the presence of bidder's representatives who choose to attend **13:00** hour at the office of **Survey Department, Min Bhawan, Kathmandu**. Bidder's shall furnish bid security (as mentioned above) which shall be valid for a minimum of 30 days beyond the bid validity period.
7. Items are grouped in package, bids on individual item is not permitted.
8. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
