4. Pre-bid meeting shall be held at **Survey Department, Min Bhawan, Kathmandu** at **13:00 hours on 17 September 2021**
5. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to the above office of **Survey Department, Min Bhawan, Kathmandu** on or before **12:00** hour on **1 October 2021**. Bids received after this deadline will be rejected.
6. Bids shall be opened in the presence of bidder's representatives who choose to attend **13:00 hour on 1 October 2021**.at the office of **Survey Department, Min Bhawan, Kathmandu**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security (as mentioned above) which shall be valid for minimum 30 days beyond the bid validity period.
7. Items are grouped in package, bids on individual item is not premitted.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
